#### **Career Overview:**

Commander Brian Hasse is a Military Professor of National Security Affairs at the United States Naval War College in Newport, RI. He is a career naval aviator with over 3000 hours in the FA-18. During his career, he's embarked on six carrier strike group deployments and has flown over 90 combat missions in Iraq, Afghanistan, Syria, and the Horn of Africa. Additionally, he has participated in multiple exercises in the Middle Eastern and Indo-Pacific theaters working with U.S. allies and partners to advance strategic initiatives. He has also served in multiple staff assignments including a tour at the United States Northern Command, where he advised senior leaders on risk management strategies to enhance the resiliency of critical defense infrastructure and networks. Most recently, he served as the 62<sup>nd</sup> Commanding Officer of the "Fighting Redcocks" of Strike Fighter Squadron 22 in Lemoore, CA. He is also a graduate student in Brown University's Political Science Department and a visiting scholar of international and public affairs at Brown's Watson Institute. His areas of expertise include air warfare, foreign policy analysis, leadership and ethics, and joint operational warfare. His research interests include political psychology, conflict management, and national security decision-making.
